The LWVHHI is pleased to announce that we have been awarded a generous grant from the Brennan Center for Justice through the LWVUS to provide financial assistance in hosting a program on the Judicial Selection Process in South Carolina.

As reported previously in *The Lighthouse*, eleven

Leagues from around the State have been hosting a programs to examine diversity in the judicial selection process and to raise awareness regarding how judges are elected in South Carolina. Ideally, such an examination may lead to opening up the system in South Carolina to embrace diversity. Although previously sched-

uled for February, 2011, the Judiciary Program hosted by LWVHHI has been moved to October, 2011 to ensure that all interested parties are represented in our examination of the issues. The details will be forthcoming.

At its December meeting, the Board decided to begin a process of including the Bluffton area in our membership. The first step of that process is to seek member approval, then approval of LWVSC and LWVUS, and ultimately change our bylaws at the Annual Meeting.

We are aware of the implications for Program and meeting times and places, but feel there are creative and League-like approaches to any challenges that we meet. Some of our current programs are already of interest to a wider area, and meeting times and places can always accommodate

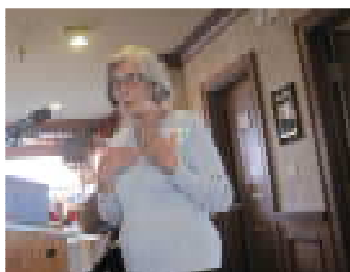
Holiday Luncheon

Meeting With Representative-Elect Andy Patrick



On December 10, seven of us from LWVHHI met with Andy Patrick, the newly elected South Carolina House of Representatives member for district 123. Our discussion covered a lot of territory and included a few laughs. Representative-elect Patrick told us that at one point he was accused of being a carpetbagger, and another time he was tagged as a good ole boy! To us he seemed to be a bright, caring young man, who is doing his homework regarding how South Carolina government works and what must be done to make it work better.

He also made it clear that he wants to be readily accessible to his constituents.

Representative-elect Patrick has been appointed to the House Committee on Education and Public Works and to its subcommittee on grades kindergarten through twelve. These appointments seem most appropriate, because

he has five school aged children, including two adopted from Russia, one of whom has special needs. Through his children, he has experience with public, private and special schools as well as home schooling. Education is obviously very important to him. He supports school choice, but only if it does not hurt the



public schools. He also believes that it's important to examine how education funds are spent. For example, he thinks the consolidation of some of the state's many school districts should be considered as a means to save money.

When asked about the Jasper Port, Patrick stated that he thinks it is ex-

tremely important. He agrees with Senator Davis that the focus should be on non-container shipping. This would keep the port from being a threat to Savannah or Charleston. He believes a regional approach, including working closely with Georgia, is essential.

Other topics we touched on included the need to revise the tax code in a comprehensive way, a view supported by the South Carolina League. However, we do not agree on voter photo identification legislation. Having worked in the security field, Patrick believes identification theft is a big problem.

It will be good to meet with Andy Patrick again, when LWVHHI members go to Columbia on February 23 for Legislative Day.

Harriet Keyserling Died December 10, 2010

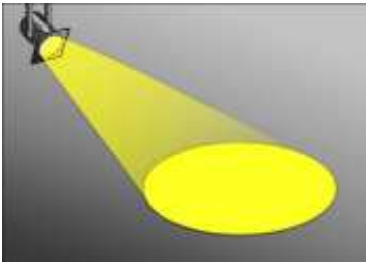
Harriet Keyserling, known and treasured by so many of us in the Hilton Head Island League of Voters, died December 10 in Beaufort, her home since she arrived there from New York in 1944 as a new bride. She is credited with helping to start

the Beaufort League of Women Voters and then volunteering to be an observer at Beaufort County Council meetings. Doing so, she observed the many areas that needed attention and decided to run for the office. She was

Spotlight On

Joan Kinne-Shulman



I first learned about the League of Women Voters from a short piece in a college American government text. The author told about a League member observing the proceedings of a local government body in California. Meeting after meeting, she sat quietly knitting as she listened. Her presence caused the officials to conduct their business in a more open way.

I thought little more about the League, except during the presidential debates in the 1960s and 1970s, until about 1977. That year my husband and I moved into a townhouse on a quiet street in Queens, New York. A neighbor told us about a League yard sale nearby. We attended. She invited me to meetings and encouraged me to join the Queens evening branch of the New York City League, which I did. From the very first meetings, I felt comfortable with League issues and procedures. I

was particularly impressed by the members, who were of a variety of backgrounds. As time went on, I took on more responsibilities in the local branch, learning more and more about public issues and how the local and state governments “really” worked.

Shortly after we moved to Hilton Head Island in January 1999, I saw a notice for a League meeting and decided to attend. Everyone was very welcoming, and I soon got more involved, taking on a variety of offices over the years. Through the League, I became familiar with local and state politics and issues and the “movers and shakers” in the community. Membership has helped me be a better informed citizen. But the best thing about being in the League has been getting to know the other members. I admire all of those who keep the League going at all levels, and I hope I can continue to make a contribution for a long time.

elected to the Council in 1974 – its first woman member. Two years later, she was elected to the SC House of Representatives, where she served for 16 years. She was known there for her analytical abilities and her success in bringing people together around an issue. She devoted her efforts to public education reform, environmental protection, promotion of the arts, energy policy and more. After her retirement, Harriet wrote about her experiences in “Against the Tide: One Woman’s Political Struggle.”

On February 28th of this year, at the Hilton Head Island League of Women Voters observance of the 90th Birthday of the League of Women Voters of the U.S., we honored Harriet Keyserling with the Making Democracy Work Award for her notable civic and legislative achievements. The wording of the award ended with “She is an inspiration to all of us who hope to make a difference through our participation in the work of the League. Thank you, Harriet – from all of us.”
