## Judicial Diversity Panel Discussion is a Success

*A Case for Diversity in South Carolina Courts*, the October program for LWVHHI/Bluffton Area, was a great success, not only because it piqued the interest of those in the audience, many of whom were attorneys drawn by the promise of CLE credits, but also because members of the panel seemed enlightened by the discussions which

took place during the presentation and afterward at a public reception. The forum was part of a nation-wide effort by the National

League to demystify the judicial selection/ election process in targeted states – one of which is South Carolina. The League's 3-fold purpose was (1) to educate the citizenry concerning how judges in South Carolina come to the bench; (2) to encourage legislators to take a fresh look at improving

the selection process; and (3) to show citizens how they might become more involved in the process.

Our panel consisted of the following members: South Carolina State Senator Tom Davis (from our local Senate district), South Carolina Representative Andrew “Andy” Patrick (from our



local House district), South Carolina Representative David J. Mack III (also a member of the Judicial Merit Selection Commission – and representing the North Charleston House district), Judge Carmen T. Mullen (circuit court judge and local resident), Kelly Jolley, JD (local attorney and leader in various capacities in the South Carolina Bar), and Barbara Zia, co-president of LWVSC. The panel spoke to an audience of approximately 70-75 people gathered at the VPAC center at Hilton Head High School. Caroline McVitty, coordinator of the Diversity

Program, acted as moderator.

Barbara Zia first spoke to the assembly about the background of the Project and what the League hoped to accomplish. Following Barbara’s comments, our moderator began asking the panel a prepared set of questions which had been earmarked for specific panelists because of their areas of expertise. The public was then invited to pose questions to the panelists. Questions concerned how potential candidates for judge-ships are recruited, how competitive South Carolina judges’ salaries are compared with other states, and whether there are formal reviews of a judge’s performance on the bench by



the attorneys who litigate before that judge. There were also questions regarding the appointment of administrative law judges and a request for partnership with the League by a minority group interested in promoting enthusiasm for voting

among minority youth. The discussion was robust.

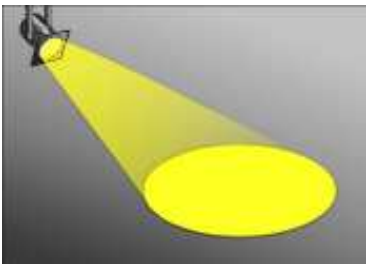
At the conclusion of the panel discussion, Barbara Zia made three



suggestions which could be implemented by the Legislature: increase the number of/change the JMSC to more closely resemble the overall diversity of the state; increase the number of applicants for consideration by the legislature; and reduce the period when candidates may campaign for support (it is presently 6 weeks). All of these suggestions appeared to be supported by the panel.
