## The League and the 2010 Census

Our October meeting will take a look at preparations for “Census 2010,” the count of everyone residing in the United States which takes place every ten years. The League of Women Voters of the U.S. has become a Census partner, to help the U.S. Census Bureau achieve as complete and accurate a count as possible. Local Leagues are encouraged to become partners also in their own communities to spread the word about the Census and its importance.

Dr. Paul L. Shepherd is a Census Bureau Partnership Specialist, based in Beaufort. He will speak to us at our membership meeting on Wednesday, October 14, about the status of the local effort to date and about the possibilities for our League to become involved in the process. We will be meeting at the Hilton Head Public Service District building at 21 Oak Park Drive, with the program starting at 10:00 a.m.

The accuracy of the Census count is very important, as the data gathered determine the distribution of more than \$300 billion annually of government funds for critical community services. The results are also used to determine the constitution of U.S. House of Representatives districts and will form the basis for redistricting of South Carolina’s House and Senate districts. As an organization dedicated to “efficient, representative, responsive and accountable state and local government,” the State League’s State and Local Government positions include strict anti-gerrymandering standards for reapportionment following each Census. Once our efforts to help ensure the accuracy and completeness of the Census here are over, we will then be most concerned with monitoring the processes that follow from it.

We look forward to seeing you at the October 14 meeting.

## From the Presidents



We were reminded last week that the health care debate has become acrimonious. A new organization calling itself the "League of American Voters" is conducting an advertising campaign against health care reform that seeks to mislead the public. In response, the League of Women Voters of the United States sent a letter asking them to stop using a name so similar to ours and building off of our credibility and reputation to undermine public support for health care reform. Their response has not been positive and the LWVUS is considering legal action.

For our part, we wrote our United States Senators and Congressmen stating our position of support for strong health care reform

legislation that includes a quality, affordable public insurance plan.

It is unfortunate that this issue has become partisan and, therefore, we must use good judgment in our advocacy. If you are contacted by the "League of American Voters" please consider using this suggested language in response:

We have sent a [letter to the leadership](#) of the League of American Voters and are awaiting a response to this communication. As you know, we have asked the League of American Voters, "to 'cease and desist' from using a name clearly designed to be confused with the League's."

## Action on State Issues

LWVSC is becoming more and more active on a variety of issues and is encouraging local Leagues, members and non-members to become more active too. If LWVSC has your correct e-mail address, you have probably been receiving e-mails alerting you to issues that need action. If you have not received them and would like to, please contact me. You can also read about the action alerts and other items of interest, including a very helpful brochure titled *Advocacy 101, When Citizens Advocate, Democracy Wins* at our state League's website, [www.lwvsc.org](http://www.lwvsc.org).

The state League's first tier action priorities for 2009-2011 are education, voter access and tax reform. The second tier priorities are criminal justice, natural resources and reapportionment. The current focus of the education priority is spelled out in *LWVSC's 2009-2010 Legislative Agenda for Public Education*, which was recently adopted by the state Board. It includes issues and actions (reprinted below without all details) as follows:

Issue 1: All children in South Carolina need and deserve the opportunity for a high quality education that will prepare them to be productive workers and thoughtful citizens.

Action: SC General Assembly enacts legislation to submit a referendum to the voters at the next general election, amending

the South Carolina constitution to state: "South Carolina will provide a high quality education, allowing every student the opportunity to reach his or her highest potential."

Issue 2: The level and distribution of funding resources should ensure that schools have what they need to provide a high quality education.

Action: SC General Assembly enacts legislation to comprehensively reform the funding formula established by the Education Finance Act.

Action: SC General Assembly enacts legislation to fully fund early childhood services, including instructional, for children who are at risk of not being prepared to enter 5K due to disabilities, development delays, and/or poverty. When state finances allow, fully fund services to children ages birth to kindergarten (5K) who are at risk.

Action: The SC General Assembly continues to oppose proposals to use public funds for vouchers or tax credits to support private school education.

Issue 3: South Carolina tax and budgetary policy should assure that funding for public schools is stable, adequate and equitable.

Action: The SC General Assembly enacts legislation to correct the most serious problems caused by Act 388. [Act 388 of 2006 provides full relief from property tax for school operations to

owner-occupied residential property in exchange for an extra 1% sales tax. It also prevents school districts and local governments from raising millage rates by more than a formula based on inflation and population growth and caps increases in the assessed value of property at 15% every five years.]

Action: The General Assembly creates an independent, permanent tax commission with adequate staff and a broad mandate to study and recommend tax policies that ensure an adequate, equitable and efficient state and local revenue structure.

At the September general membership meeting, Senator Tom Davis indicated that dealing with the problems caused by Act 388 will be very important at the upcoming legislative session.

It will not be easy to make the needed changes, because, unlike Beaufort County, most school districts have benefited from the act. Stay tuned to see what happens and how we might help.

## United States Census Information

The League of Women Voters has taken on the 2010 Census as a central project for the upcoming year. Leagues across the country have begun establishing partnerships with their local census offices to ensure every resident is counted. Nationally, we have officially partnered with the Census Bureau and joined the national *Ya Es Hora, Hagase Contar!* ("It is Time, Make Yourself Count!") Campaign along with NALEO, Television, SEIU, and others.

### General Description of the U.S. Census:

Article I, Section 2, of the U.S. Constitution mandates a headcount of everyone residing in the United States. The first Census was conducted in 1790 and has been carried out every 10 years since then.

The 2010 Census will be mailed to all households in March, consisting of a short-form, **with 10 questions** that will take **10 minutes** to complete. The census will count all residents living in the United States as well as ask for name, sex, age, date of birth, race, ethnicity, relationship and housing tenure – taking just minutes to complete.

Census data is important because it:

- impacts how more than \$300 billion per year in federal and state funding is allocated to communities for neighborhood improvements, public health, education, transportation and more.

- determines how data is also used to apportion seats in the U.S. House of Representatives and to redistrict state legislatures and;

- determines how Census data are used to define legislature districts, school district assignment areas and other important functional areas of government.

The census is like a snapshot that helps define who we are as a nation. Data about changes in your community are crucial to many planning decisions, such as where to provide services for the elderly, where to build new roads and schools, or where to locate job training centers.

Let's work together to make it happen right!!
